

SHEEPHERDER'S BREAKFAST


One-dish casseroles thats a sure hit with the breakfast crowd!

INGREDIENTS:

- 3/4 pound bacon strips, finely chopped
- 1 medium onion, chopped
- 1 package (30 ounces) frozen shredded hash brown potatoes, thawed
- 8 large eggs
- 1/2 teaspoon salt
- 1/4 teaspoon pepper
- 1 cup shredded cheddar cheese

INSTRUCTIONS:

- 1. In a large skillet, cook bacon and onion over medium heat until bacon is crisp. Drain, reserving 1/4 cup drippings in pan.
- 2. Stir in hash browns. Cook, uncovered, over medium heat until bottom is golden brown, about 10 minutes. Turn potatoes. With the back of a spoon, make eight evenly spaced wells in potato mixture. Break one egg into each well. Sprinkle with salt and pepper.
- 3. Cook, covered, on low until eggs are set and potatoes are tender, about 10 minutes. Sprinkle with cheese; let stand until cheese is melted.

BACKCOUNTRY HORSEMEN OF CALIFORNIA SAN JOAQUIN SIERRA UNIT

The Rancheria Work Party went in to work the Rancheria Trail on Friday June 29 and came out on Monday July 1. All work was completed on wilderness and non-wilderness trails leading to wilderness.

Approximately 3.1 miles of Rancheria Trail was cleared from the trailread to Rancheria creek. Approximately 1.75 miles from Duck Lake turn off towards Duck Lake was also cleared. Also on two days trail was cleared of Whitethorn brush to the trail standard of eight foot wide to the landing approximately 500'. This alone took about 20 hours by a three person team. In addition on Monday July 1 four trees were cleared from road to trailhead.

Trail was cleared of a number of trees: 20" X 15' 3cuts 30" X 12' 1cut 3" X 6' 1cut 18" X 12' 3cuts 24" X 4' 1cut 18" X 6' 1cut 8" X 10' 2cuts 36" X 30' 1cut 36" X 10' 3cuts 32" X 14' 1cut 32" X 30' 1cut 24" X 8' 1cut 8" X 20' 1cut 26" cuts 1 12" cut X12' split tree 6" X 10' 1cut 8" X 15' 1cut complex 8" X 40' 3cuts complex wilderness hand saw 8" X 30' 1cut 12" X 20' 1cut 18" X 8' 2cuts

JHA's were gone over prior to start of work and daily tail gates were done. All PPE required gear was used by all volunteers. No accidents or close calls occured.

SHAVER LAKE HORSE CAMP Camp is Open

BCHC San Joaquin Sierra Unit again makes the Shaver Lake Horse Camp available for use by members and associate members wishing to enjoy camping and riding at Shaver Lake.

Shaver Lake is situated at elev. 5,300 ft. within the Sierra National Forest on scenic recreational land. There are ample riding destinations, as the camp itself is adjacent to the 12.5 mile Perimeter Trail that surrounds the lake. Also in the vicinity are the Ely Mountain and Balsam Forebay Trails.

The camp is located behind a locked gate, 1 mile East of Highway 168 on Dinkey Creek Road. It is a dry camp, with portable sanitary facilities. There are two tables, a fire pit and 3 stalls. Fire regulations apply; cookstoves can be used on the table top. And, of course, campers must Leave No Trace.

California's Greatest Lakes.com describes Shaver Lake as "one of the most enjoyable vacation lakes in California", with a "balmy, 78-degree average high temperature." This writer has enjoyed many pleasurable hours riding and appreciating a picture-perfect view at every turn. Make your plans and reservations now to enjoy a perfect mountain experience for both you and your horse.

The camp will be open May 24 through October 31, 2019, for SJSU members only. Cost is per membership—\$10/day for camping, \$5/day for picnic use. Other units are welcome to use the camp after joining as Associate Members (\$15 additional).

While the Vansickles are long time horse owners, and Gary has extensive back country hiking experience, neither had ridden in the mountains before. At the beginning of the 2 hour ride at Tamarack, above Shaver Lake, safety and what to expect on the trail was discussed. As we rode along sometimes on a smooth open trail and then over and around a variety of natural obstacles the best way to navigate these were talked about as well as how to keep ourselves oriented so we could find our way back to the trailers. And of course what to do if you run into "meat bees". The creek was flowing well and we made several water crossings, talked about how to ride at the edge of meadows to minimize damage, crossed a wooden bridge, rode over large rocks, boggy trails and through the trees and bushes to get around fallen trees. The day was fun for all and the best part was that Sue said she felt more confident riding out and looks forward to the next session. Rides will be scheduled to increase in difficulty each time. Future destinations are Ely Mountain above Shaver Lake, Twin Lakes near Kaiser Peak and the Horse Camp trail out of Courtright Lake. Riding in the back country adds another whole dimension to enjoying your horse. And you might even get the bug to join in the trail work parties with campouts. Several experienced back country riders have volunteered to go along for safety and to share their knowledge. And to have fun! Objectives & Purpose of the Backcountry Horseman of California From the BCHC Bylaws

- To improve and promote the use, care and development of California backcountry trails, campsites, streams and meadows; to advocate good trail manners.
- To promote the conservation and utilization of our backcountry resources in concert with livestock transportation.
- To keep the backcountry trails and forage areas open to horseman on all public lands.
- To keep current information before the Corporation membership and its local Units regarding new legis-lation or management plans related to government regulations of the backcountry.
- To support or oppose new proposals, plans and restrictions as related to the interest of horsemen and those persons interested in recreational stock use and enjoying the backcountry.
- To promote the interest of people who, due to health or physical factors, need transportation other than by foot on backcountry trails.
- To promote public awareness and interest in the historical aspect of horsemen and stock in the back-country and to help educate backcountry users on the ways to use the trail and foraged in a manner that conserves the backcountry resources.
- To assist in keeping the public informed of the vital need for a clean backcountry.
- To promote a working relationship with and keep the work and interests of the Corporation before our local, state and federal officials.
- To assist in the formation and continuation of local Units to carry out these purposes.
