#### **DUTCH OVEN CHILI MAC**

Blending the best of both worlds, chili mac combines the smoky and spicy flavor of chilli with the rich and creamy texture of mac & cheese. It's an all-American camping classic and using this recipe, you can make it using just a single pot!

#### **INGREDIENTS:**

- 1 tablespoon oil
- 1 onion, diced
- ½ pound ground beef
- 2 tablespoons tomato paste
- 2 tablespoons chili powder
- 1 tablespoon cumin
- 1 teaspoon smoked paprika
- 1 teaspoon sea salt

- 2 cloves garlic, minced
- 8 oz elbow noodles
- 1 (14.5oz) can kidney beans, drained
- 1 ½ cup broth, beef or vegetable
- ½ cup shredded cheddar cheese

#### TO SERVE:

minced red onion, jalapeno, scallions



#### **INSTRUCTIONS:**

- 1. In a Dutch oven or other large pot with a lid, heat the oil over medium heat. Add the onion and saute until translucent, 3-5 minutes.
- 2. Add the ground beef, tomato paste, chili powder, cumin, smoked paprika, and salt. Using your spoon or spatula, break apart the meat and stir to coat with the tomato paste and spices. Once browned, add the garlic and saute for 30-60 seconds.
- 3. Add the noodles, kidney beans, and broth and stir. Cover with the lid and cook for 5-6 minutes (unless the noodle packaging denotes a different cooking time).
- 4. Remove the lid and stir in the cheese. Serve with your favorite chili toppings.

# GENERAL MEETING AND UNIT ELECTIONS

Your San Joaquin/Sierra Unit held the annual Unit Elections and General Meeting on Tuesday, October 18, at the Clovis Elks Lodge. The meeting was called to order at 6:30 p.m., by President Joe Kaminski and the fun began. The purpose of the meeting was to elect officers for the upcoming year, and to consider a By-Laws change.

First, though, everyone enjoyed visiting with friends over a pizza dinner. Tickets were available for the 2023 Rendezvous raffle items: a Henry "Silver Eagle" 22 cal. Carbine Rifle, or a \$500 Bass Pro Shop Gift Card. (If you missed out, there will be plenty of opportunities to get your tickets).

The election was held, and the By-Law changes were approved. Our by-laws currently require that no one may hold the same office more than four years. The change adds "unless there is no one running for the position." This change allows the treasurer, for example, to continue in that position. Additionally, the term of service for officers changed from one (1) to two (2) years. Going forward, the president and secretary will be elected one year, the treasurer and vice-president the next year, and so on.

As a result of the by-law changes, the following were elected to a 2-year term:

The Board members elected for 2-year terms are: Sue Van Sickle, Jim Laber, Marcee Hansen and Jan Mikkelson

The highlight of the meeting was a presentation by Paul Barile. Riders in the Shaver/Kaiser Pass area might have crossed paths with him. He is a cowboy/ packer who works cattle in the winter and packs out of Cunningham Pack Station in the summer. Paul presented an "Armchair Travelogue" of his pack trips along the John Muir trail between Yosemite Park and Mt. Whitney. The highlight of his presentation was the photos and video of Paul and his pack string crossing Forrester Pass, the highest pass in the US

crossed by stock. It was a very enjoyable evening, that brought back memories to some in the audience and, hopefully, inspired others to plan their own pack trip to the beautiful high Sierras. # DESERT RIDE AT STARLIGHT RANCH NW OF ROSAMOND CA





#### February 17-19, 2022

We were made aware and found Indian Petroglyphs in this area last year and will be taking a ride to them on Saturday. A Breakfast to be provided by 9:00am Saturday and Sunday. Potluck Dinner Saturday, we will provide the main course and please bring an item to share. We need **RSVP by February 13th**. Need to bring water for you and your horse and anything else you want to drink. Some beds available but need to secure with us. Terrain is simple to difficult depending on trail, with all trails being packed to loose desert soils that are easy on the hoofs. Most of the trails/roads are a gradual climb but depends on what you want to do. Clean up needs to be done behind horses/stock and distributed outside fence. Take out all other that you bring in. There is an outhouse on the property and a flush toilet in the house. May want to bring your own toiletries to be safe. The gate at the ranch will be open at noon on the 17th and property will be cleared and gate closed by 2pm Sunday the 20th.

**Directions:** LAT: 34.924709 LON: 118.382792 Starlight Ranch is already tagged on google maps if you use that. The map shows traveling on what is called Aqueduct RD but you want to go 30' further on Backus Rd, to what we call Upper Aqueduct RD where you will see a large Rock painted with a Smiley Face. Although the lower road can be used to get there, there are more obstacles and a large dip that larger trailers may have issues with. Take CA Hwy 99 south to CA Hwy 58 East

out of Bakersfield to Tehachapi about 43 miles. Exit at Tehachapi Blvd and go Right on Tehachapi Blvd. Loves Truck Stop will be on your Right. Continue on Tehachapi Blvd for 1 mile and go Right on Willow Springs Road and follow for 16.0 miles where you will turn Right on Backus RD. Backus RD is paved for about 1.2 miles When you come to the end of the pavement you will see a dirt road to the right that you will proceed on. The rest of the trip is on dirt roads. You will continue on, Dirt Backus RD over a short bridge and on to Upper Aqueduct RD. You will see a large rock painted with a Smiley Face. Turn left and continue on Upper Aqueduct RD for 3.6 miles to 140th St. (Note: Google tries to get you to turn prior to Rd 140. Do not take that turn. That's the hard way. We will have the way marked with BCHCSJSU Directional signs along the dirt road). There will be a curved dirt road leading to the right onto 140th St and most will want to take that. You will then see a sign on your left that says Starlight Ranch. Go left before the sign and drive straight back about 100 feet and through the gate to the ranch. You will need to bring water for overnight stays. The ranch is cyclone fenced but horses/stock will need to be tied up. There are just 3-4 highline areas first come first serve. There are some bed opportunities in the house and out buildings on the property but please call to claim. Jim and Doug Laber will be hosting the ride at the Starlight Ranch which is owned by Family. We will have a generator there that gives us lights in the house in the evenings. There is a large patio and fire pit for gatherings. Firewood if you have it will help and we will be bringing some out with us. It can get very cold and or very windy at the ranch so be prepared for that. Hope to see you there! # WILDERNESS RIDER HISTORY



Backcountry Horsemen of California created an education program known as "Gentle Use" around 1992 to encourage its membership to accept, promote and follow the ideals and principles of wilderness ethics described as Gentle Use (GU) while enjoying their time in the wilderness areas of this great state. This name was suggested by the newly formed education committee which included: Ken Savage, Ralph Looney, Charley Morgan, Marily Reese and Dena Mercer. This program was an active part of the early Rendezvous held in the Porterville and Visalia areas.

In 1996, the Sequoia National Forest and Yosemite National Park hired a young college graduate by the name of Barb Miranda to the position of Wilderness Education Project Director. She was requested to promote the Leave No Trace (LNT) principles to two important users of the wilderness:

the Boy Scouts of America and anyone riding a horse.

She was looking for a partnership and found a horseman contact by the name of Larry Difani, the State Education chair of BCHC. The LNT program was accepted by the agencies and BCHC saw a great opportunity for the future partnership.

In the early part '96, it was decided to have three members of BCHC attend a Stock LNT Master Course and create a similar course for members of our organization who wanted to encourage others to

actively use the GU/LNT principles. Those individuals were: Larry Difani, Tom Stovall and Bob Olin (who would also be the Forest Service Representative).

These men held the first "Ghost Rider" course in Yosemite National Park in the fall of 1996. This name was chosen by Barb but was soon changed because of copyright claims by another volunteer group. The existing group of 10 with the instructors decided on the name "Wilderness Riders" which Bob Olin suggested.

The following spring a Wilderness Rider by the name of Ruthie Heuer would be the fourth Stock Master of LNT and was to evaluate the BCHC course compared to the Master course, suggest any improvements and bring more teaching ideas to the program.

It was at this Master Course that Ken Graves was also a participant and would join BCHC in a few years as the Forest Service LNT Coordinator for the Pacific Southwest Region.

There have been many other individuals, not mentioned above, who have been instrumental or

involved over the years in supporting and furthering this program throughout the state. They have acted as cooks, teachers, promoters, etc and are: Peggy Whitaker, Jerry Ledbetter, Sandy Newsome and Dave Moser. Those who are the acting instructors at this date are: Ruthie Heuer, Jo Johnson and Donna Meier along with agency personnel Ken Graves.

The agency personnel and Wilderness Rider Steering Committee of BCHC met in December of 2008 for a review and evaluation of the program. Both entities believed this program is one of the most successful partnerships involving volunteers in the state and will continue this important education program.

# WILDERNESS RIDER CODE OF CONDUCT

Our Wilderness Riders are governed by the Wilderness Rider Steering Committee that insures each member adhere to the Code of Conduct.

In the performance of duty as members of the Wilderness Riders, volunteers should: 1. Be polite at all times when dealing with the public, agency contact and the media; 2. Treat other volunteers, agency employees and other organizations with courtesy and sensitivity; 3. Through proper risk management practices ensure that the activity being undertaken is suitable for the age, experience and ability of the individual and educate them as to their responsibilities in contributing to a safe environment; 4. Take the personal initiative to learn, respect, communicate and adhere to the rules of the agency contact.

Personal Behavior Wilderness Riders agree to: 1. Consistently display high personal standards and project a favorable image of the program;

- 2. Strive to achieve the highest quality, effectiveness and dignity in both the process and products of volunteer work without promoting self-interests;
- 3. Refrain from public criticism of fellow volunteers, management committee or users;
- 4. Abstain from the use of alcohol products while on duty;
- 5. Not abuse alcohol or drugs;
- 6. Refrain from the use of profane, insulting, harassing or otherwise offensive language in the conduct of any duties;
- 7. Avoid harm to others;
- 8. Be honest and trustworthy;
- 9. Respect the privacy and opinions of others;
- 10. Regularly seek ways of increasing professional development and self-awareness;
- 11. Be passionate about the program and become an advocate in their community.

Volunteers Must: 1. Ensure the safety of the people with whom they work. 2. Ensure that they do not discriminate on the basis of race, color, national origin, gender, religion, age, disability, political beliefs, sexual orientation, and marital or family status. 3. Respect the dignity of others; verbal or physical behaviors that constitute harassment or abuse are unacceptable.

Public Comment While in uniform and/or performing volunteer duties they are in effect representatives of the federal land management agencies and the Backcountry Horsemen. As such they should not offer personal opinions or publicly criticize government policies or other organizations and must respect information given in confidence. As interested citizens Wilderness Riders should feel free to comment orally or in writing on public land management issues, but should do so as citizens, not as representatives of the Wilderness Rider program.

For that reason your unit board of directors has made this shirt availble for safety on trail rides and work parties as well as a way to promote our unit and its activities.



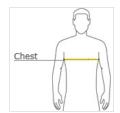

Measure under the arm and around the fullest part of the chest with arms down, keeping tape



- To improve and promote the use, care and development of California backcountry trails, campsites, streams and meadows; to advocate good trail manners.
